Rules of Entry

You can enter at any local International Design Guild affiliated showroom by completing the registration form. All submissions should include an EPS, TIFF or other high-resolution photo of the room design, as well as a short essay on the inspiration behind the design, the challenges and pros and cons of the design, and a brief description of the floor covering material used. There is no cost to register or enter; however, flooring products featured in the design must have been purchased through an International Design Guild affiliated showroom.

Contest begins on March 16, 2009 and ends at 11:59 p.m. on June 23, 2009. All entries become the property of International Design Guild and will not be returned. Photographs and design descriptions may be used in future publications and articles in any of either International Design Guild's or its members' marketing materials. By submitting an entry, Entrant represents to Sponsor that Entrant has all rights to use or otherwise reproduce the photograph(s) submitted in Entrant's entry, including model release(s) of any models appearing in the photographs. Sponsor assumes no responsibility for illegible, lost, late, misdirected, incomplete, or stolen entries or mail for entries that are unable to process due to network, hardware, or other technical failures.

On or about August 14, 2009, the membership of International Design Guild will vote and announce all Designer Showcase Award winners. The awarding of any prize is contingent upon the full compliance with Official Rules; winner may be subject to other verification and eligibility requirements. Entrants agree to be bound by Official Rules and agree that if the winner fails to provide proof of identity, refuses to provide required affidavit, is found to have violated the Official Rules or otherwise does not meet eligibility criteria, prize(s) will be forfeited and awarded to an alternate winner of International Design Guild's choosing.
